3. After filling the application form, request you to download and take a print for attesting the signatures of all applicants. Then use the above option to upload the application form duly signed by all applicants and KYC Documents into our portal.
4. Kindly note, without submitting the application form the allotment of bonds will not be done. It will be kept on hold till the submission of application form to RTI (i.e. KFinTech - Hyderabad).




Step 5:- After Downloading the Form and Duly filling it, Take a Scan of the Signed Application alongwith KYC Documents.




