1. Introduction

Welcome to the REC 54EC Bonds Mobile Application. This user manual will guide youthrough the features and functionalities of the app, ensuring that you can effectively manage your REC 54EC Bonds investments.



2. Getting Started

2.1. Installation

- Download the REC 54EC Bonds Mobile Application "SUGAM-REC" from the App Store (iOS) orGoogle Play Store (Android).
- Install the application on your mobile device.

2.2. Registration and Login

• Upon opening the app, you will be presented with options to register or log in.





- If you are already having investment in REC's 54EC Capital Gain Bonds and have received the Bond Certificate, kindly use your PAN, mobile number and email ID to register.
- If not registered or not having any existing investment with REC, you can use the app as a guest with limited features, such as access to Important Forms, Fresh Investment link, and Query Window.
- Once logged in using the PAN, the mobile token will be securely stored, enabling subsequent logins through biometric authentication such as Face ID or fingerprint recognition, obviating the need for the user to manually input the PANdetails again.










3. User Dashboard

- From the dashboard, user can access various features and functionalities.








4. Investment Summary

5. Important Forms

- All the essential forms related to the investments such as change in bank details, change in nominee, change in address, etc shall be available for download in PDF format.
- All the documents along with the necessary attachments will have to be submitted to RTA's office at the address as mentioned in the forms.








6. Allotment Advice and e-Bond Certificate

- The e-bond certificate downloaded shall be equally valid as the physical bond certificate dispatched from the company.








7. Fresh Investment

- Complete application can be filled and paid for online through net banking via this seamless website experience.








8. Query Window

 - Users may connect via the Toll-Free number.








9. Logging Out
