Dear Sir(s),

In compliance with the provisions of SEBI (LODR) Regulations, 2015, it is informed that the entire shareholding of REC Transmission Projects Company Limited (RECTPCL), a wholly owned subsidiary of REC Limited in Lakadia Banaskantha Transco Limited & Jam Khambaliya Transco Limited, comprising of 50,000 equity shares, have been transferred along with all its assets and liabilities on November 13, 2019, to Adani Transmission Limited, the successful bidder selected through Tariff Based Competitive Bidding Process for "Transmission system associated with RE generations at Bhuj –II, Dwarka & Lakadia" and "Jam Khambaliya Pooling Station and Interconnection of Jam Khambaliya Pooling Station for providing connectivity to RE projects (1500 MW) in Dwarka (Gujarat) & Installation of 400/220 kV ICT along with associated bays at M/s CGPL Switchyard" respectively.

In terms of the Guidelines/directions issued, from time to time, by Ministry of Power, Government of India, RECTPCL has received consideration from the successful Bidder for sale and transfer of both the subsidiaries as follows:
