REC, under the Ministry of Power, is a Non-Banking Finance Company (NBFC), which provides long-term loans and other financing products to states, Centre and private companies for creation of infrastructure assets in the country.

According to a company statement, on a standalone basis, its loan disbursements increased to Rs 1,15,470 crore in first half of the fiscal from Rs 90,955 crore, up by 27 per cent.

During Q2 FY26, loan sanctions have increased by 97 per cent to Rs 1,49,832 crore against Rs



76,200 crore in corresponding quarter of previous fiscal.

Owing to growth in all the verticals, it stated that the REC is able to maintain its spreads at 2.89 per cent and NIM (net interest margin) at 3.64 per cent, resulting in a robust half yearly profit after tax of Rs 8,877 crore.

As a result, the annualised earnings per share (EPS) for the period ended September 30, 2025 accelerated by 19 per cent to Rs 67.24 per share as against Rs 56.56 per share as at September 30, 2024.
