**ORDER**

**Subject: Constitution of Task Force for developing the Roadmap for India Energy Stack and PoC for Utility Intelligence Platform**

1. As part of the ongoing digitalization initiatives in the Power Sector, India Energy Stack has been envisioned as a Digital Public Infrastructure (DPI) to provide standardization and interoperability across various segments of the Power Sector. The proposal to develop a roadmap for the India Energy Stack, along with the PoC of the Utility Intelligence Platform, has been approved by this Ministry under the Revamped Distribution Sector Scheme (RDSS) with REC Ltd. as the Programme Nodal Agency and FSR Global as the Knowledge Partner for the initiative.
2. In view of the above, a Task Force is being constituted comprising domain experts and various stakeholders involved in the DPI ecosystem and the Power Sector, to chart a roadmap for the India Energy Stack and prepare the scope for developing the Utility Intelligence Platform. Supporting them will be expert groups from across the value chain.


